

On Ice at Piccadilly Schools Risk Assessment



L = Likelihood, S = Severity, R = Risk (Likelihood and severity assessed as Low (L), Medium (M) or High (H))

Risk is established by multiplying likelihood by severity (the highest level of risk prevails e.g. L x H = H).
